

## ***Why we need your help***

### **Your regular giving, preferably by Bank Standing Order:**

- provides the Parish with regular income towards costs in excess of £670 per day;
- helps us take responsible decisions about the work of the parish;
- makes possible the recovery of tax from the Inland Revenue.

### **Giving by Gift Aid costs you nothing:**

- It allows 22p of tax to be reclaimed for every 78p you give.
- Signing the declaration form costs a taxpayer nothing extra and does not affect tax codings.
- Higher rate taxpayers can get their tax bill reduced by 25p for every £1 they give the parish – and 50% taxpayers will be able to recover even more.

## ***Giving Profile***

In 2009 we received £164,000 from 169 planned givers.

In considering how much to give you may wish to be aware of the breakdown of what we currently receive:
